INTRODUCTION

Progress report for 2012 describes the progress of implementation of projects, namely activities, as envisaged in the MSIP 2012-2014.

The report also strives to identify projects and other activities implemented in the mining sector, which have not been included in the MSIP plan 2012-2014.

This report identifies the progress achieved and challenges for non-implementation of certain projects/activities.

Identification of challenges shall serve as facilitation in addressing issues which may be considered an obstacle for further development of the sector, and will facilitate adequate planning, implementation and more detailed analysis of planning costs and time of project implementation.

As a result, the annual progress report shall serve as a basis for mining development policy review, which could be reflected in the Mining Strategy Review.



Progress Report 2012, in relation to the Mining Strategy Implementation Program 2012-2014 (PR for 2012, for MSIP 2012-2014), has been drafted in line with the Law on Mines and Minerals No. 03/L-163, Mining Strategy of the Republic of Kosovo 2012-2025 and MSIP 2012-2014

MED- DECPEI has coordinated the drafting process of the progress report, which the included the following relevant institutions of the mining sector: MED-DEM, MED-KGI, KEK, Trepça – PAK, ICMM, MESP and INKOS j.s.c.

Initially, DECPEI developed a reporting template through tables/fiches, which lists projects envisaged in MSIP in 2012. In addition, working meetings with the aforementioned institutions were chaired by DECPEI. The first meeting (i) was used to discuss the reporting form and manner, and the second meeting (ii) to discuss the progress of each project for 2012, included in the MSIP 2012-2014. In addition to meetings, DECPEI, as needed, contacted relevant institutions and discussed on relevant issues.


